**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

**Applicability.** Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

**Definitions.**

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

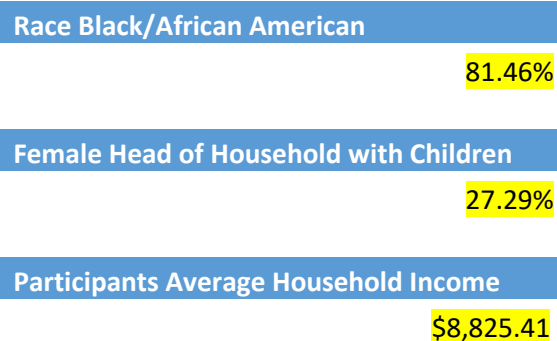
## Admin Plan Updates

There are no admin plan updates.

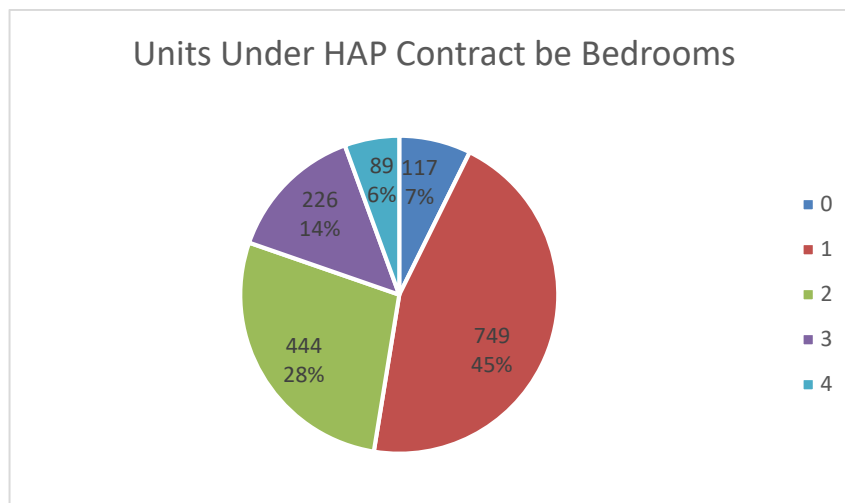
## Additional Status Update

LHA has received HUD funding for 1,575 baseline units.

As of **December 1, 2020**, there are **1,484** households included in the program, of which 90% are categorized extremely low income. The average household gross annual income is **\$8,825.41**. All households are classified as disabled, **27%** are female heads of household with children and **81%** are Black/African American.



**1,625** units are under Housing Assistance Payment contracts. These units are broken down as follows: **117 (6%)** studio units, **749 (45%)** one-bedroom units, **444 (28%)** two-bedroom units, **226 (14%)** three-bedroom units, **89 (6%)** four-bedroom units. There are an additional **69** units under an Agreement to enter into a Housing Assistance Payment Contract.



New units for the program will be brought on, in part, through the award of vouchers to projects from the Louisiana Housing Corporation's Notice of Funding Availability that included 4% Low Income Housing Tax Credits, HOME and disaster CDBG funds and from the award of vouchers to projects from the Qualified Allocation Plan that provided favorable treatment for proposals containing program units. Vouchers will be allocated based on waiting list demand. There are approximately **2,533** households on waiting lists.

## **B.2 New Activities**

The LHA has been Section 811 Mainstream vouchers that the LHA will administer as tenant-based vouchers. Section 811 Mainstream vouchers administered in partnership with the Louisiana Department of Health (LDH) are expected to non-elderly disabled assist families statewide with LDH or its designee providing case management.

## **B.7 Resident Advisory Board (RAB) comments**

The RABs are active statewide. RAB meetings were held during at various times during year 2020. An overview of the PSH program was presented at each meeting with a strong emphasis on the importance of submitting documents required annually to avoid termination of assistance. There were no comments received about the 2021 PHA draft plan.

### **B.7 (a) Challenged Elements**

There were no challenged elements noted during the 45-day comment period or during the December 23, 2020 public hearing.
