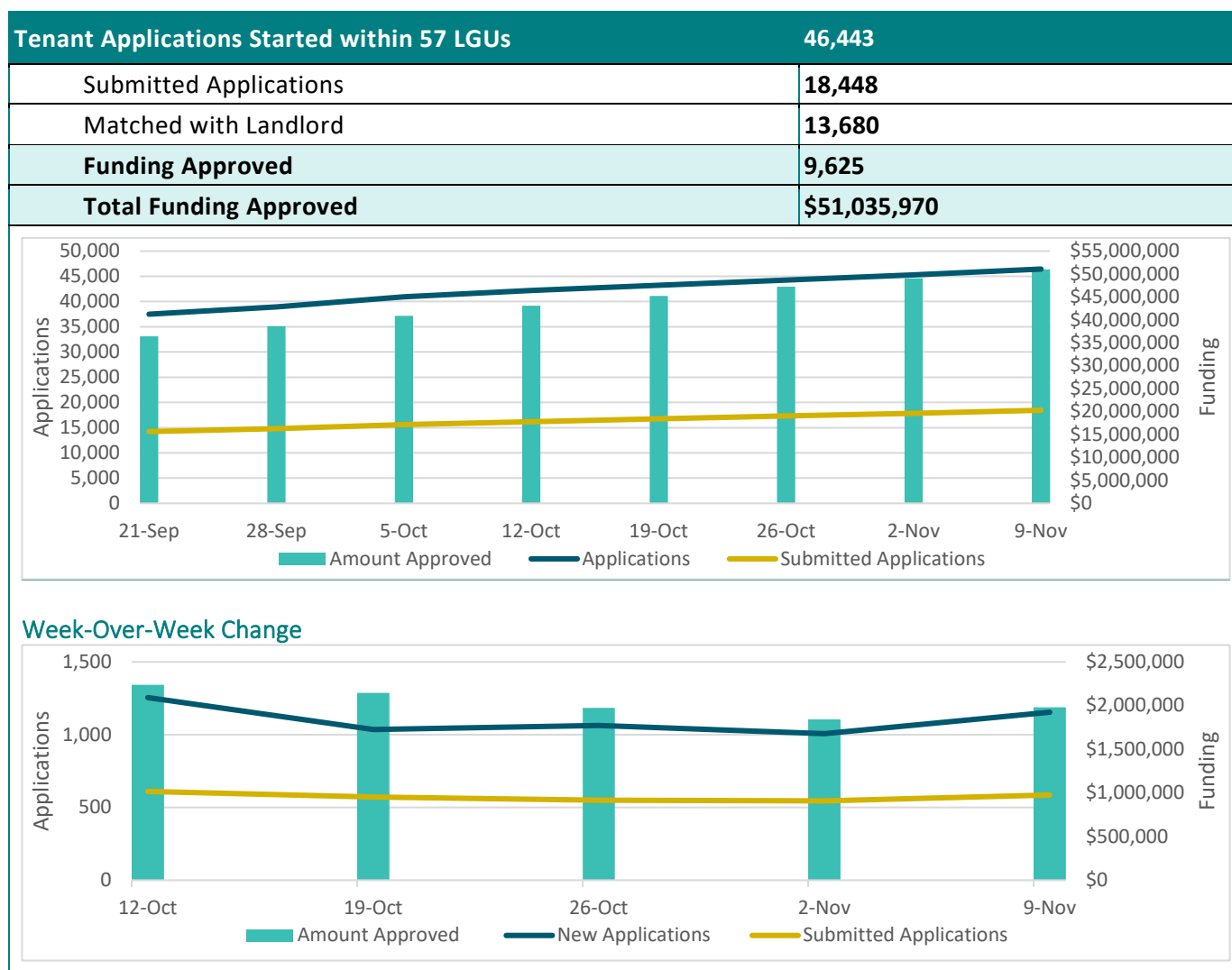




# WEEKLY STATUS REPORT

NOVEMBER 9, 2021 / UPDATED AS OF 9 A.M.



- Nearly \$2 million approved for payment last week, similar production over the past 4 weeks
- 1,155 new applications started last week
- Average award is \$5,328 per tenant
- 910 tenants have received direct payments totaling \$3.37 million due to unresponsive/uncooperative landlords
- 18,314 utility payments requested (can be multiple per tenant and paid upon rent approval)
- 4,834 utility requests approved for payment, totaling \$2.7 million



#### Notes/Commentary

- Agreement reached with CSRS on new task order beginning November 1 and ending April 15, 2022. The task order is for a maximum of \$4.9M and will finish out any remaining state ERAP 1 funds remaining (over \$60M). Task order provides funding for additional case managers; five new case managers starting November 1.
- Program prioritizing applicants with eviction notices on file – 2,605 total approved since August 1. An additional 1,898 applicants with eviction notices are under review or in final approval
- Web traffic increased 7% last week, with highest number of web visits from the Baton Rouge area, followed by Monroe, New Orleans, Hammond and Bossier City. Most are accessing the site through a Google search and direct URL link and via smartphone.
- Billboard ads remain active through next week.
- CEA signed with Southern University Law Center to enable eviction diversion pilot program in Hammond, Monroe, and Alexandria

#### Notes/Commentary

- Sent formal request to Treasury on 10/1 to request “voluntary reallocation” with LGUs. Treasury issued reallocation guidance on 10/4 that will likely require adjustments to allocation amounts listed above—awaiting Treasury feedback. We are continuing to process requested funding for LGUs that have no funding left.
