


WEEKLY STATUS REPORT

OCTOBER 12, 2021 | UPDATED AS OF 9 A.M.



- More than \$2.2 million approved for payment last week, similar production over the past 4 weeks
- 1,255 new applications started last week
- 610 applications submitted last week
- Average award is \$5,433 per tenant
- 474 tenants have received direct payments totaling \$2.09 million due to unresponsive/uncooperative landlords
- 14,786 utility payments requested (can be multiple per tenant and paid upon rent approval)
- 3,285 utility requests approved for payment, totaling \$1.97 million



Notes/Commentary

- Program prioritizing applicants with eviction notices on file 2,037 total approved since August 1. An additional 1,647 applicants with eviction notices are under review or in final approval
- Continuing to work with LHC to identify housing stability and eviction diversion opportunities to fund, including but not limited to, legal services and housing counseling. Developing pilot eviction diversion program with Southern University Law Center with focus on Monroe, Alexandria, and Hammond city courts.
- Funding for current task order with CSRS will be exhausted at end of month. Reviewing proposal from CSRS to issue another task order to finish ERAP1 state program.
- Web traffic decreased 27% last week as broadcast and digital media campaigns ended. 77% accessing webpage via smart phone. Billboard ads will remain active in October. Coverage data for TV and radio will be available beginning next week. Based on results and outcomes, additional advertising may be recommended.
