18. **(ACTION)** Resolution of intention to **issue not exceeding Fifteen Million Dollars, (\$15,000,000) Multifamily Housing Revenue Bonds for Parkview Apartments Project** located at **1101 Richwood Road #2, Monroe, Ouachita Parish, Louisiana 71202**, in one or more series to finance the acquisition, construction, rehabilitation, and equipping of a multifamily housing development within the State of Louisiana; to establish the maximum qualified basis and low-income housing credits to Parkview Apartments Project; to authorize the staff and counsel to prepare the forms of such documents and agreements as may be necessary **to allocate 4% Low-Income Housing Tax Credits** to such facilities.
19. **(ACTION)** Resolution of intention to **issue not exceeding Twenty-Four Million Dollars, (\$24,000,000) Multifamily Housing Revenue Bonds for KHA Affordable Properties Project** located at **1013 31st Street, Kenner, Jefferson Parish, Louisiana 70065**, in one or more series to finance the acquisition, construction, rehabilitation, and equipping of a multifamily housing development within the State of Louisiana; to establish the maximum qualified basis and low-income housing credits to KHA Affordable Properties Project; to authorize the staff and counsel to prepare the forms of such documents and agreements as may be necessary **to allocate 4% Low-Income Housing Tax Credits** to such facilities.
20. **(ACTION)** Resolution authorizing a **change in the site design from four (4) buildings to three (3) buildings for Ravendale Apartments**, located on **Ravendale Road in Shreveport, Caddo Parish, Louisiana**; authorizing the Corporation staff and counsel to prepare the forms of such
