CALL TO ORDER

On a motion by Board Member Steven P. Jackson and seconded by Board Member Alfred E. Harrell, III, the Minutes of the March 22, 2022 LHC Board of Directors Meeting were unanimously approved, as distributed.

LHC EXECUTIVE DIRECTOR'S REPORT

LHC Executive Director Joshua G. Chairman Marullo thanked ED Hollins and everyone for their hard work.

Official Delegate Board Member Tony Ligi applauded the progress of LHC under the administration of ED Hollins; and he updated everyone on SB 201 by State Senator Sharon Hewitt to allow for electronic public meetings.

Secretary Brooks introduced the item; there was additional information provided by ED Hollins.

On a motion by Board Member Alfred E. Harrell, III and seconded by Board Member Richard A. Winder, the resolution commemorating the 55th Anniversary of the Fair Housing Act and declaring the month of April 2023 as "Fair Housing Month"; and providing for other matters in connection therewith, was moved to debate. There being no further discussion, opposition, or public comment, a vote was taken, and the motion passed unanimously.

Next item discussed was regarding \$45M MHRB for Tivoli Place located in New Orleans.

Secretary Brooks introduced the item.

On a motion by Board Member Steven P. Jackson and seconded by Board Member Vice-Chairwoman Tonya B. Mabry, the resolution of intention to issue not exceeding Forty-Five Million Dollars (\$45,000,000) Multifamily Housing Revenue Bonds for Tivoli Place located at 1040 St. Charles Avenue, New Orleans, Orleans Parish, Louisiana, in one or more series to finance the acquisition, construction, and equipping of a multifamily housing development within the State of Louisiana; to establish the maximum qualified basis and low-income housing credits to Tivoli Place; to authorize the staff and counsel to prepare the forms of such documents and agreements as may be necessary to allocate 4% Low-Income Housing Tax Credits to such facilities; to accept the proposal of Stifel, Nicolaus & Company, Incorporated or such other purchaser as may be designated by the Taxpayer for the purchase of said bonds; and providing for other matters in connection therewith, was moved to debate. There being no further discussion, opposition, or public comment, a vote was taken, and the motion passed unanimously.

ADJOURNMENT

There being no other matters to discuss, Board Member Steven P. Jackson offered a motion for adjournment that was seconded by Board Member Willie Rack. There being no discussion or opposition, the motion passed unanimously.
