On a motion by Board Member Jennifer Vidrine and seconded by Board Vice-Chairwoman Tonya B. Mabry, the resolution abolishing all previous delegations of authority and recognizing MARJORIANNA WILLMAN, Interim Executive Director of the Louisiana Housing Corporation, as the Authorized Signatory for the Louisiana Housing Corporation; was approved by the Committee and moved that the matter be recommended FAVORABLY to the Board at the October 12, 2023 Board of Directors Meeting.

On a motion by Board Member Jennifer Vidrine and seconded by Board Vice-Chairwoman Tonya B. Mabry, the resolution to authorize and approve LHC Interim Executive Director Marjorianna Willman's salary at \$230,000.00 per annum during the time that she is serving as "LHC Interim-Executive Director," retroactive to September 29, 2023; was approved by the Committee and moved that the matter be recommended FAVORABLY to the Board at the October 12, 2023 Board of Directors Meeting.

# **AGENDA ITEM #7 - LHC EXECUTIVE DIRECTOR SEARCH**

Next item discussed was regarding the LHC Executive Director Search.

The matters were introduced into the Record by Secretary Brooks, there being additional information provided by representatives from SSA Consultants and Sexton Law Firm.

Regarding the ED Search, the Board's attorneys at Sexton Law Firm will work closely with SSA Consultants to ensure the objectives and expectations of the Board are met.

Cody Saucier, SSAC Project Team Member, will work in tangent with Dr. Christel Slaughter on the ED Search, with a targeted timeline of December bringing to the Board their recommended candidate(s).

Periodic updates on the ED Search will be discussed at future Administration Committee Meetings.

The Administration Committee will also review the Candidate Profile and Scope of Services, along with monitoring the Proposed Timeline.

On a motion by Board Vice-Chairwoman Tonya B. Mabry and seconded by Board Member Jennifer Vidrine, the resolution authorizing the Louisiana Housing Corporation to contract with SSA Consultants for LHC Executive Director Search consulting services; was approved by the Committee and moved that the matter be
