The following resolution was offered by Board Member Steven P. Jackson and seconded by Board Member Jennifer Vidrine:

RESOLUTION

A resolution authorizing the Louisiana Housing Corporation ("LHC" or "Corporation") to issue a Request for Proposals ("RFP") to seek proposals for Consulting Services for Homelessness and Housing Voucher Programs; and providing for other matters in connection therewith.

WHEREAS, the Louisiana Housing Corporation ("LHC" or "Corporation") was created by and pursuant to the Louisiana Housing Corporation Act contained in Chapter 3-G of the Louisiana Revised Statutes of 1950, as amended (R.S. 40:600.86 through R.S. 40:600.111);

WHEREAS, the LHC, as authorized by the State of Louisiana pursuant to R.S. 40:600.91(A), shall have the powers necessary or convenient to carry out and effectuate the purpose and provisions of the LHC Act; and

WHEREAS, the LHC Board of Directors and Staff have recognized the need for having a firm or a pool of firms to provide consulting services for technical assistance with the various programs currently administered or that may be administered by LHC during the term of the contract(s) arising in response to the RFP.

NOW THEREFORE BE IT RESOLVED by the Board of Directors of the Louisiana Housing Corporation, acting as governing authority of the Louisiana Housing Corporation, that:

SECTION 1. The Corporation is hereby authorized to issue a Request for Proposals, ("RFP") to seek proposals for Consulting Services for Homelessness and Housing Voucher Programs as directed by the Corporation.

SECTION 2. The Corporation is directed to solicit responses from vendors and to rank and score those responses and thereafter award a contract to the highest scoring proposer and execute a contract after all delays for appeal have run as provided in the LHC Procurement Policy.

SECTION 3. The Chairman, Vice Chairman, Executive Director, and/or Secretary of the Corporation are hereby authorized, empowered, and directed to execute any forms and/or documents required to be executed on behalf of and in the name of the Corporation, the terms of which are to be consistent with the provisions of this resolution.
