## **RESOLUTION**

**A resolution authorizing the Louisiana Housing Corporation ("LHC") to issue a Notice of Funding Availability ("NOFA") to seek proposals from entities to provide Homelessness Prevention Services using HOME-ARP funding for Rapid Rehousing and Supportive Services; and to provide for other matters in connection therewith.**

**WHEREAS**, the Louisiana Housing Corporation (the "Corporation") has entered an agreement to administer the HUD HOME-American Rescue Plan ("HOME-ARP") and HUD CDBG-DR 2020-2021 programs as permitted in the Powers and Duties of the Corporation enumerated in La RS. 40:600.91; and

**WHEREAS**, in Louisiana there is a need for the provision of Homelessness Prevention Services using HOME-ARP funding for Rapid Rehousing and Supportive Services to assist people experiencing homelessness:

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Directors of the Louisiana Housing Corporation (the "Corporation"), acting as the governing authority of said Corporation that:

**SECTION 1.** The LHC is authorized to issue a Notice of Funding Availability ("NOFA") to seek proposals from entities to provide Homelessness Prevention Services using HOME-ARP funding for Rapid Rehousing and Supportive Services.

**SECTION 2.** The Chairman and Executive Director of the Corporation be and they are hereby authorized, empowered and directed to execute any forms and/or

documents required to be executed on behalf of and in the name of the Corporation, the terms of which are to be consistent with the provisions of this resolution as approved by the Corporation's Counsel.




