RESOLUTION

A resolution approving the inclusion of Lakeview Loan Servicing, LLC, a Delaware limited liability company in the definition of Master Servicer under the Series 2024C/D/E Program.

WHEREAS, Master Servicer under the Forty-Seventh Series Supplemental Indenture is currently defined to mean initially Standard Mortgage Corporation, or another servicer as may be selected by the Corporation; and

WHEREAS, the Corporation has been advised that the addition of Lakeview Loan Servicing, LLC, a Delaware limited liability company is desirable to close out the Series 2024C/D/E Program as the Corporation transitions to a new open Indenture and the Series 2025A/B Program; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Louisiana Housing Corporation, acting as the governing authority of said Corporation, that:

- **SECTION 1.** The Board hereby approves Lakeview Loan Servicing, LLC to be co-master Servicer under the Series 2024C/D/E Program.
- **SECTION 2**. The Board approval of Lakeview Loan Service, LLC shall take effect immediately.
- **SECTION 3.** The Corporation staff and counsel are authorized and directed to prepare any ancillary documents as may be necessary to implement the Board's actions.
- **SECTION 4**. The Chairman, Vice Chairwoman, and/or Secretary of the Corporation are hereby authorized, empowered, and directed to execute any forms and/or documents required to

be executed on behalf of and in the name of the Corporation, the terms of which are to be consistent with the provisions of this resolution.
