The following resolution was offered by Board Member Alfred E. Harrell, III and seconded by Board Member Willie Rack:

RESOLUTION

A resolution recognizing every June hereafter in perpetuity as Homeownership Month, and providing for other matters in connection therewith.

WHEREAS, the Louisiana Housing Corporation ("LHC" or "Corporation") was created by the Louisiana legislature and entrusted with the mission to ensure that every Louisiana resident is granted an opportunity to obtain safe, affordable, energy-efficient housing; and

WHEREAS, the LHC believes that homeownership is an important part of the American Dream and that a home provides shelter and a safe place where families can prosper and raise children; and

WHEREAS, the LHC sees that owning a home is an important financial investment for families, and an important part of community stability; and

WHEREAS, the U.S. Department of Housing and Urban Development ("HUD") partners with the LHC to make the most effective use of its funds through a combination of down payment assistance, tax incentives, and education about the process and responsibilities of homeownership; thereby helping citizens of Louisiana buy homes and pursue a better quality of life.

NOW, THEREFORE, BE IT RESOLVED by the Board, acting as the governing authority of the Corporation, that

SECTION 1. Every month of June hereafter in perpetuity shall hereby be recognized as Homeownership Month.

SECTION 2. The LHC hereby fully supports the goals and ideals of Homeownership Month, formally recognizes the importance of Homeownership Month in building strong communities and families, and reaffirms the importance of homeownership in the economy and stability of Louisiana and its central role in our continued prosperity.

SECTION 3. The LHC's support and recognition of Homeownership Month shall include extended outreach efforts to heighten the awareness of the importance of homeownership and the role that LHC can play for those seeking to purchase a home in realizing their dream of being homeowners through the provision of its programs, products, and services.


