The meeting of the Single Family Committee was called to order by Ms. Danette O'Neal, Chairperson, on March 21, 2007 at 9:22 a.m. in the V. Jean Butler Board Room at Louisiana Housing Finance Agency, located at 2415 Quail Drive, Baton Rouge, LA.

The approval of the December 13, 2006 Single Family Committee Meeting Minutes were motioned by Commissioner O'Neal and seconded by Commissioner Austin.

Updates on the 2007A, 2006D, 2006C, 2006BR, 2006B, 2006AR, and 2006A Bond Issues, Loans by Lender, Loans by Parish and Whole Loan Report were given by Morise Duffin.

Update on transition with Standard Mortgage was given by Morise Duffin.

There were three brief presentations given on alternative mortgage products. The presenters explained several different mortgage products and how they can be used with the programs that LHFA already provide.

- A. Gary Williams of Fannie Mae presented the Community Renovation Product which enables borrowers to purchase a single-family property, including condominiums, or a 2-4 unit property with a low down payment and finance renovations having a total cost of up to 50 percent of the completed value of the property. A borrower can purchase a home and make renovations and repairs in a single mortgage.
- B. President Milton Bailey presented the Single Family Mortgage Revenue Bond Program which provides reservation or set aside revenue bond fund for developer finance initiative. When a developer is looking for construction financing, the developer and the bank agree on construction financing; the bank will be able to set a trailer up in front of the developing site and will have an exclusive on making loans. The benefit being it provides the bank with a guaranteed source of take out. Additionally the lender is in a position to leverage construction financing for that development by providing mortgage origination in that development site. Bankers are also given the opportunity to convert new residents within that community into new banking customers. If the bankers participate on the purchase of the bonds that are issued they can also benefit from CRA credits. The feature benefit is while you have a going out rate that is equivalent to the same rate that you have on your mortgage revenue bond, the developer also has an opportunity to buy down rates exclusively for the purchase of homes at that development site. Proved successful in six of the Hope VI projects in Washington, D. C.

C. Guy Yandel of George K. Baum & Company presented three exhibits:

- 1) The LHFA Mortgage Loan Product Comparison which states the different types of loan products which are FHA, Conventional (LHFA Monthly), Conventional (LHFA Split Premium), Conventional (Market, FICO>620), Conventional (Market, FICO<620), Conventional (Market, FI
- 2) The State Agency Program Finance Comparison which shows sixteen different types of loan products and those products used by each state.
- 3) The State Agency Program Borrower Comparison which shows twenty different types of borrower programs used by each state.

That it is recognized that a real necessity exists for the employment of bond counsel in connection with the delivery of the Series 2007B Bonds and, accordingly, Foley & Judell, L.L.P., as Bond Counsel, and The Godfrey Firm, P.L.C., as Co-Bond Counsel, both of New Orleans, Louisiana, be and they are hereby employed as bond counsel and co-bond counsel to the Agency to do and to perform comprehensive, legal and coordinate professional work with respect thereto. The fee to be paid bond counsel and co-bond counsel shall be an amount based on the Attorney General's then current Bond Counsel Fee Schedule and other guidelines for comprehensive, legal and coordinate professional work in the issuance of revenue bonds applied to the actual aggregate principal amount issued, sold, delivered and paid for at the time the Series 2007B Bonds are delivered, together with reimbursement of out-of-pocket expenses incurred and advanced in connection with the issuance of the Series 2007B Bonds, subject to the Attorney General's written approval of said employment and fee.
