A resolution authorizing the Louisiana Housing Corporation to issue a Request for Proposals ("RFP") seeking proposals for Contract Loan Servicer and providing for other matters in connection therewith.

WHEREAS, the Louisiana Housing Corporation ("LHC" or "Corporation") was created by and pursuant to the Louisiana Housing Corporation Act contained in Chapter 3-G of the Louisiana Revised Statutes of 1950, as amended (R.S. 40:600.86 through R.S. 40:600.111); and

WHEREAS, the Louisiana Housing Corporation has been ordered and directed to act on behalf of the State of Louisiana in allocating and administering programs and/or resources made available pursuant to the HOME and Mortgage Revenue Bond Programs; and

WHEREAS, the Corporation recognizes the need for a contract loan servicing company; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Louisiana Housing Corporation, acting as the governing authority of the Corporation, that:

SECTION 1. The Corporation's Staff is hereby authorized and directed issue a request for proposals from qualified firms who desire to serve as a Contract Servicer.

SECTION 2. The Corporation's staff, Financing Team and/or Corporation's Counsel are authorized and directed to prepare any documents, agreements and take appropriate actions, as may be necessary, for the issuance of request for proposal for a Contract Servicer.

SECTION 3. The Chairman, Vice Chairman, Executive Director, and/or Secretary of the Corporation are hereby authorized, empowered, and directed to execute any forms and/or documents required to be executed on behalf of and in the name of the Corporation,
