Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. The Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

Additional Updates

LHA has received HUD funding for 1,574 baseline units. LHA also has received funding for Special Purpose Vouchers as follows: VASH vouchers, Mainstream vouchers, Emergency Housing Vouchers.

As of December 1, 2023, there are 1,579 households included in the program, of which 90% are categorized extremely low income. This includes the following number of households in the Special Purpose Voucher programs: for VASH vouchers, for Mainstream vouchers and for Emergency Housing Vouchers. For all programs, the average household gross annual income is \$11,948.00. All households are classified as disabled, 46% are female heads of household with children and 80% are Black/African American.

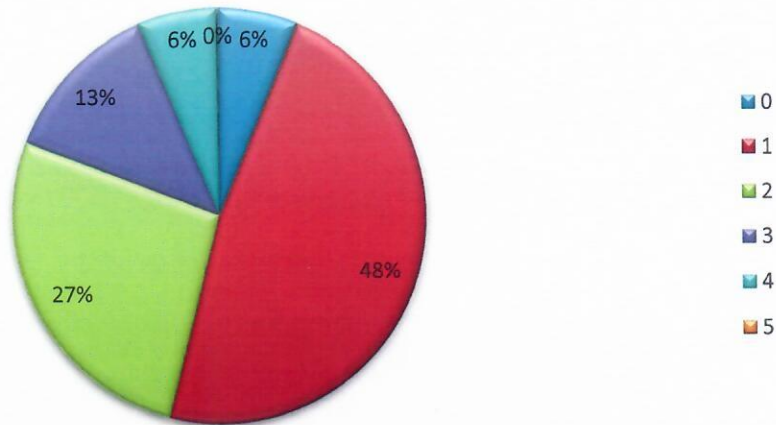

These units are broken down as follows: 113 (6%) studio units, 859 (48%) one-bedroom units, 482 (27%) two-bedroom units, 231 (13%) three-bedroom units, 112 (6%) four-bedroom units, and 2(0.1%) five bedrooms. There are a total of 80 vouchers reserved for developers who were provided tax credits for unit set asides. Developments in construction phase are due to finalize construction years 2025 and 2026.

B.2 New Activities

The LHA has expanded the Housing Choice Voucher program adding Tenant Based Vouchers to its portfolio; therefore converting the administration of the Permanent Supportive Housing Project Based Voucher program to a Permanent Supportive Housing program that administers both Project-Based and Tenant-Based Vouchers and has expanded throughout the state Continuum of Care.

B.7 Resident Advisory Board (RAB) comments

The RABs are active statewide. The first RAB meeting occurred various times throughout state of Louisiana during the 2024 year. An overview of the PSH program was presented at each meeting with a strong emphasis on the importance of submitting documents required annually to avoid termination of assistance. This meeting will cover the inspection process and importance of keeping units sanitary. Comments regarding the 2025 PHA draft plan are pending.
